1. Rental Fees for Use of Halls and Ancillary Spaces for Events

The fee for the use of the event hall includes the required areas and ancillary spaces of the hired hall. The costs for the supply of energy, cleaning and basic technical equipment, for the security service provided by the Lessor (admission control, cloakroom staff, ushers) and a maintenance worker for preparing the event equipment in the hall are covered in the rental fee.

The basic rental for artistic events comprises a maximum of three hours of event time, get-in and/or rehearsal time from two hours before the start of the event and get-out time up to one hour after the end of the event.

The regular operating hours of the building are from 07:30 to 00.00. The actual rental period begins with the provision of access to the backstage area and/or hall, and ends after these areas have been vacated. Invoicing is based on the number of started hours.

Unless otherwise stated, all rental fees are net prices (excluding VAT).

The calculation of the graduated rental fee is based on the highest ticket price requested by the Lessee including all price components (any value-added tax, HVV public transport fees), but excluding advance booking, shipping and payment charges.

The halls must open to the public no later than 30 minutes, and the foyers no later than 90 minutes before the start of the event.
